Course Objective:

Welcome to the study of Education Law. This course strives to provide perspective and understanding of the basic legal concepts and mechanics of the law applicable to K-12 education. This class will cover topics including, but not limited to, Public Information and Records Management, Open Meetings Act, Special Education/504, State and Federal Liability and Immunities, First Amendment Issues, Fourteenth Amendment Issues, Teacher Contracts, and Student Discipline/Harassment/Bullying.

Reading Material:

Required:

There is no textbook for this class. In lieu of a text, course material may be picked up from Anjanette Curtis's desk in the LSS Suite beginning May 1st. The cases have been redacted for clarity and brevity. There is no charge for the material.

You are expected to be able to discuss the assigned reading in depth, so please make a commitment to be prepared. Your advanced preparation gives you the best opportunity to correctly synthesize and participate in our class discussion.

Office Hours:

If you have any questions about the course, please ask us. Questions are welcome and encouraged. We are available after class and by appointment. Professors Brush and Davis can be found in the LSS Suite, Room 15J.

Attendance Requirement:

Consistent with the university policy, 80 percent attendance in class is required. A class roll will be circulated each day and each student must initial the appropriate square next to his or her name for the particular date of attendance. Initialing the roll indicates that the student will be in attendance for the entire, and not part, of the class session. Each student is responsible for initialing the roll sheet at each class meeting. If the sheet is not initialed before the professor leaves the classroom at the end of a session, students who have not initialed the roll for that class will be considered and counted absent. Students will not be allowed to argue at a later time that they were actually present on days in which the class roll was not initialed. Those individuals not satisfying the attendance requirement will be reported to UH Law Center administrative officials and may be dropped from the course.

Grading:

Your grade will be based on two short assignments, participation, and the final exam. The assignments will be brief (1-2 page) writing exercises. The exam will consist of short answers and be open book. The examination and assignment will be discussed as the week progresses.

Student Participation:

Students with poor class participation may have their final grade dropped by 1/3 of a letter grade. The decision to drop a grade for participation is at my discretion and is non-negotiable. A drop in class participation can result from a combination of unpreparedness, not paying attention in class, and absences (even if you are within the six-absence limit). In rare circumstances, a student may go up a 1/3 of a letter grade for making a substantial contribution to the class. Note that volunteering every class does not constitute a substantial contribution—quality, not quantity matters.
